## c. INWARD HANDLING TARIFF

## 1. SEAFREIGHT

From arrival at Tanjung Perak to exhibition stand inclusive of removal and temporary storage of empty packing cases (where applicable) at site or vice versa:

## The above charges excluding:

- Insurance;
- Temporary storage for empty case;
- Overtime/holiday (Sunday, Public holiday) Forklift/man power(if any) 50% from total handling;
- Extend permit charges (if any);
- Add. Job request, the charges will be followed.

## d. OTHER SHIPPING CHARGES (where required)

a. COURIER OF PRINTED MATERIALS – BROCHURES, PAMPHLETS, CATALOGUES ETC With weight below 100 Kgs per shipment.

From arrival at PT Agility International's premises up to delivery to exhibition stand.

#### b. HEAVYLIFT SURCHARGE

Individual exhibit in excess of 2,000 kg per package will incur heavy-lift surcharge (in addition to the basic handling charge).



These additional heavy-lift surcharges are applicable severally for inward movements as well as for outward movements.

#### c. CRANAGE

For sake of safety, all containers must be grounded to facilitate stuffing or un-stuffing of containers. Our charges for grounding loaded containers and reloading of empty containers at site are:

#### d. UNSTUFFING / STUFFING OF CONTAINERS

Additional charges for unstuffing and / or stuffing of containers or for container delivered to site for on-site handling only.

#### e. TRANSFER OF CONTAINERS

Return of empty containers from site to shipping line depot or collection of empty containers from depot to site (carnage charge is applicable)

#### f. PERMANENT IMPORTATION FOR SOLD GOODS

Permanent importation	USD 250.00 per consignment (HBL or HAWB) per

All goods sold must be transferred into the Customs bonded warehouse pending the completion of duty payment formalities. Duty payment formalities would usually take 2 to 3 weeks to be finalized.



#### g. HANDLING OF 'SOLD GOODS' TO BONDED WAREHOUSE

This is applicable on 'sold goods' which have to be transferred from the exhibition site to the bonded warehouse after the show closes and loading to the truck. For cargo exceeding 5,000 kg, heavy lift surcharges will be applicable.

Handling Rate	USD 35.00 per CBM or 1,000 kg whichever is greater.
Minimum charge	USD 100.00 per consignment per exhibitor.

Additional costs incurred for import duties/taxes and redelivery charges to buyer/agent in Indonesia will be quoted on application.

#### h. CUSTOMS BONDED WAREHOUSE STORAGE

This is applicable on exhibits arriving before the show and storage after close of the event.

Customs storage charge	USD 0.60 – USD 2.00 per CBM per day
Minimum charge	USD 35.00 per consignment per exhibitor

#### i. DISPOSAL CHARGE

All goods that are left behind at the stand meant for disposal will be cleared / disposed by us and a disposal charge will be imposed.

#### j. VALUE ADDED TAX (PPN)

A Value Added Tax (PPN) at 10% of the invoiced value will be levied for all charges applicable.

## **CUSTOMS REGULATIONS**

## **SALE OF EXHIBITS**

Goods may be sold during the exhibition but under no circumstances can they be removed from the Fairgrounds until duties/taxes have been paid and permanent customs import procedures have been completed.

Meanwhile, these goods are required to be removed to a bonded warehouse until the necessary documentation is completed. The minimum period needed to process permanent customs import document is 3 weeks. Exhibitors are allowed to store their goods in their facility for up to 1 month from the close of the exhibition, after which duty must be paid or the goods to be re-exported

#### NOTE:

All computation of duties/taxes will be based on the HS Code indicated on FORM Pam. The Customs Authorities are empowered to amend the HS Code and uplift the declared CIF value based on the new/uplifted value.

The Indonesian Customs Amendment Rights is valid for ten (10) years from date of import and exhibitors or buyers shall be responsible for all misdeclarations. In such cases, heavy penalty and the balance of duty/taxes must be paid accordingly.

#### **BROCHURES AND GIVEAWAYS**

Conversion of documents for brochures and giveaways is subjected to a fee of **USD 50.00** per exhibitor (excluding duties/taxes, if applicable).

#### **INSURANCE**

We would like to advise that it is the responsibility of each exhibitor to arrange Marine (Transport) Insurance covering transport to the exhibition, during the exhibition, and the return of the exhibits to



domicile, including the period the exhibits are handled by PT Agility Fairs & Events, and also ensure that Transport Insurance in arranged for exhibits sold locally.

Upon written instructions, PT Agility Fairs & Events can offer the exhibitor insurance coverage at competitive premiums.
